Membership Renewal

Membership Types (a refresher, in case you want to change your membership status):

Active (\$10.00 dues, paid yearly.) This is for those individuals who can and will participate in Society activities in at least one of the following three ways: **a.)** undertake a management role in the Society (as an office holder or committee member); **and/or, b.)** take an active part in the maintenance of the gardens (as one of our work-day worker-bee volunteers); **and/or, c.)** regularly attend and participate in our monthly meetings.

Household: (\$15.00 dues, paid yearly.) This is the same as an Active Membership, except it covers more than one person. This category is for families in which one, or more, individual(s) is/are active in the Society in at least one of the ways described for Active Memberships (above). Other family members may be interested in the Society but participate on a less than active basis. Household members must all reside at the same address.

Associate: (\$15.00 dues, paid yearly.) This category is for those who care for the Society and wish to support it, but who cannot be active in its operations on a regular basis (at least, that is, as fully as one of the ways described for Active Memberships). Associate Members are very important to the Society. Although they are not fully 'active' members, they may, and from time to time often do, participate in Society activities.

Lifetime: (\$100.00 dues, paid once.) This category lets you avoid the need to make annual dues payments. Lifetime Members may be either active or inactive participants in Society activities. The money paid for a Lifetime Membership goes into the Society's Endowment Fund. Lifetime Membership payments are income tax deductible. (We are a federally registered charitable organization.) There are absolutely no restrictions on who may become a Lifetime Member, or when they may do so. Many applicants choose this option when first joining.

Renewal Procedure:

Timing: Membership renewals are payable every year between January 1 and April 30, and no later than May 1. Renewals paid after May 1 will only be accepted in the full amount, and they will only be applied to the remaining month(s) of the current fiscal year (May 1 thru April 30).

Payment: The amount of your renewal payment will vary, depending on the type of membership you have selected. (See "Membership Types and Dues" above.) When paying by check, make it payable to the "Sarasota Succulent Society". When submitting your renewal in person, cash or check will be accepted.

Delivery Options: 1.) By U.S. Mail: send this renewal form and your check to The Sarasota Succulent Society, 1310 38th St., Sarasota, FL 34234; **or** 2.) By hand, by submitting this form and your payment to our Treasurer, or to another officer: **a.)** at any one of our regular monthly meetings; **or, b.)** at any workday session in the Gardens; **or, c.)** at any one of our annual public sales.

Renewal Form:

Important: Renewals must be accompanied by enough information for us to be able to match your renewal information and your renewal payment to an existing membership record, so please include your full contact information on the renewal form.

Please: Make sure your contact information is printed clearly, paying particular attention to the letter-by-letter readability of all information provided. In email addresses especially, it is important to distinguish between alpha "i", alpha lower-case L "l", and numeric "1", as well as between alpha "o" or "0" and numeric zero "0".
